1. COMPANY PROFILE:

UKMRC has been setup by Government of Uttarakhand as a special Purpose Vehicle for Implementation and operation of Rail Based Mass Rapid Transit System (Metro) in selected cities of Uttarakhand.

2. JOB DESCRIPTION AND RESPONSIBILITIES:

Incumbent of the post will report to the Company Secretary of the Company. He will be responsible for the overall finance, accounting, taxation, audit and other related matters of the Corporation.

3. ELGIBILITY:

I. AGE (as on 01.11.2017) :

Maximum –58 years

II. QUALIFICATION AND EXPERIENCE:

1- Graduation in any discipline.

2- Officers working in any Metro Rail Corporation or Indian Railway and/or Graduation in Commerce/Intermediate in CA/ ICWA will be given preference.

III. PAY SCALE:

Should be working in Rs. 9300-34800 (Grade Pay 4200) (Level-6 of 7th pay commission) (for Central Govt. officers)

OR

In Rs. 14000-26950 IDA Scale in any PSU

OR

In Rs. 13500-25520 IDA scale in any PSU at least for 3 years

Note-The officers should be working in finance department of their organization.

4. PRIORITY IN SELECTION

The selection will be done on the basis of following priority:-

- I. On Deputation from any Metro Rail Corporation.
- II. On Deputation from any PSU/ Central Govt.
- III. On Direct Recruitment from any Metro Rail Corporation.
- IV. On Direct Recruitment from any PSU/ Central Govt.

5. DURATION OF APPOINTMENT:

- I. The appointment on deputation shall be for a period of 3 years. Further extension shall be as per DOPT Guidelines.
- II. The appointment on Direct Recruitment shall be till the date of superannuation. General age for superannuation will be 60 years unless extended otherwise.

6. SUBMISSION OF APPLICATIONS:

- i. Prospective candidates should send their application in the format at Annexure-I furnishing a comprehensive Bio-data including name, date of birth, address for communication, details of qualifications and experience covering organization, position held, areas of responsibility and emoluments drawn etc. along with two copies of passport size photographs.
- ii. The applications should accompany, inter-alia, a write up on the significant contributions made by the candidates during their present/past assignments and their suitability for the post as per the eligibility requirements.
