COMPANY PROFILE:

UKMRC has been setup by Government of Uttarakhand as a special Purpose Vehicle for implementation and operation of Rail Based Mass Rapid Transit System (Metro) in selected cities of Uttarakhand, with Headquarters at Dehradun.

1. JOB DESCRIPTION AND RESPONSIBILITIES:

The Candidate shall be responsible for the overall functions of finance and Accounts where work shall be related to the fields such as taxation, audit and other related matters of the Corporation. The incumbent shall have the knowledge of corporate accounting, financial management, taxation-direct/indirect, treasury management, corporate governance, tender evaluation, vetting of contracts/offers/estimates etc.

ELIGIBILITY:

I. AGE

For working officers: not more than 58 years as on 30.06.2018

QUALIFICATION AND EXPERIENCE:

- 1- Master Degree in Commerce/ICWA/ CA will be preferred.
- 2- Working Knowledge of handling financial matters of large projects. He/she must possess of 18 years of post-qualification executive grade experience dealt with areas like Project finance, Finance, Accounting and Audit, setting up Financial, Accounting system and procedures, exposure of issuing Domestic and Foreign currency bonds.

3- Should have worked with statutory auditor/ internal auditor of Government/PSU/Metro Rail Companies.

4- Candidates having knowledge of SAP/ERP will be preferred.

II. PAY SCALE:

Rs. 37400-67000 (Grade Pay 10000) (Level-14 of 7th pay commission) for Central Govt. employees /PSU.

Or

Working in Rs. 51300-73000 IDA in any Government organisation/ PSU Officers/Metrorail Corp for atleast 3 years.

2. PRIORITY IN SELECTION

The selection will be done on the basis of following priority:-

- i. On Deputation from any Metro Rail Corporation/Central Govt./PSU.
- ii. On Direct Recruitment from any Metro Rail Corporation/Central Govt./PSU.

3. DURATION OF APPOINTMENT:

- i. The appointment on deputation shall be for a period of 3 years. Grant of further extension can be considered as per DOPT Guidelines.
- ii. The appointment on Direct Recruitment shall be till the date of superannuation. At present, the age for superannuation is 60 years.

4. SUBMISSION OF APPLICATIONS:

- i. Prospective candidates should send their application in the format given at Annexure-I, duly furnishing comprehensive Bio-data, including name, date of birth, address for communication, details of qualification and experience covering organization, position held, areas of responsibility and emoluments drawn etc., along with two copies of passport size photographs.

The application should accompany, inter-alia, a write up on the significant contributions made by the candidates during their present/past assignments and their suitability for the post as per the eligibility requirements.
