**COMPANY PROFILE:**

UKMRC has been setup by Government of Uttarakhand as a special Purpose Vehicle for implementation and operation of Rail Based Mass Rapid Transit System (Metro) in selected cities of Uttarakhand, with Headquarters at Dehradun.

**1. JOB DESCRIPTION AND RESPONSIBILITIES:**

Candidate shall be responsible in carrying duties of to check survey work, Calculate, coordinates to handle total station and other modern surveying instruments. Experience in urban transportation project survey work

**ELIGIBILITY:**

**I. AGE**

For working officers: not more than 58 years as on 30.06.2018

For retired officers: should have retired on or after 30.06.2018.

## **ii. QUALIFICATION AND EXPERIENCE:**

- a) Three year diploma in Civil Engineering from any Govt. recognised University/Board Or Two year course in Surveying from Govt. ITI.
- b) The officer should have varied experience of working in Railway/Metro Rail Corporation/PSUs in Civil/Construction Department and should be conversant with functioning in computerized environment. Hands on knowledge on various computer applications, relating to the job is also desirable. Officers should be free from D& AR and vigilance enquiry.

## **PAY SCALE:**

For Central Govt. or PSU officer, on deputation: Rs.5200-20200 Grade Pay Rs. 2400/- (Level of 4) as per 7th CPC.

Or

For PSU officers working in IDA pay scale for atleast 3 years on Deputation and for Direct recruitment Rs. 10170 - Rs. 18500/-.

Or

For Retired Officers: From Govt. Dept. PSU's/Metro Rail Corporation/ PSU's. Rs. 29000/- PM Consolidated.

## **2. PRIORITY IN SELECTION**

The selection will be done on the basis of following priority:-

- I. On Deputation from any Metro Rail Corporation /Central Govt./ PSU/.
- II. On Re-employment /Contract basis retired from Metro Rail Corporation/ Central Govt./ PSU.
- III. On Direct Recruitment from any Metro Rail Corporation/ Central Govt./ PSU.

## **3. DURATION OF APPOINTMENT:**

- i. The appointment on deputation shall be for a period of 3 years. Grant of further extension can be considered as per DOPT Guidelines.
- ii. The Contract of working/retired officers shall be initially for a period of one year, further extendable upto the age of 65 years.
- iii. The appointment on Direct Recruitment shall be till the date of superannuation. At present, the age for superannuation is 60 years

#### 4. SUBMISSION OF APPLICATIONS:

- i. Prospective candidates should send their application in the format given at Annexure-I, duly furnishing comprehensive Bio-data, including name, date of birth, address for communication, details of qualification and experience covering organization, position held, areas of responsibility and emoluments drawn etc., along with two copies of passport size photographs.
